"2024 Planning and Zoning Case Law Update" In this session we will aim to develop a better understanding of planning and zoning concepts by exploring how and why courts addressed issues that arose out of actual planning and zoning decisions.

"Shifting from Conflict Management to Positive Communication" It's human nature to avoid confrontation, while anger and disrespect aimed at elected and appointed officials is an ever-growing problem. The combination is making good people walk away from important roles in local government. Plus, it's becoming even more difficult to find residents willing to step forward to serve. Perpetual conflict affects the entire community in countless ways. This session will offer some perspective, as well as suggestions for fostering improved communication.

"Growing Sustainability – The Triple Bottom Line Approach in Local Government Planning and Operations" Municipalities, particularly in New York State, are consistently "on the hunt" for new investment. How do we ensure that future growth and development don't overtax our ability to deliver great services, a connected community, and protect the natural environment? This session will focus on case studies for communities employing a "triple bottom approach" to growth – asking tough questions about financial, social, and environmental sustainability in development proposals.

"SEQR Basics" The State Environmental Quality Review Act (SEQRA) is a complex law with requirements subject to wide interpretation. If you are Planning Board or Zoning Board of Appeals member, it is vital you understand SEQRA to make decisions on the applications before you. This is a session intended not only for new Board members, but for everyone who wants a SEQRA refresh.
